



RELOCATION TERMS & CONDITIONS ADDENDUM

This document contains a summary of the special conditions for relocation bookings. It is to be used in conjunction with the Cruisin' Motorhomes Terms and Conditions and will make up part of the Rental Agreement. Where Relocation Terms and Conditions are different from the Cruisin' Motorhomes Terms and Conditions the Relocation Terms and Conditions apply. Rates quoted are in Australian dollars.

Maximum Relocation Days & Free Kilometres

Subject to availability we are offering the following days and free kilometres per route. Extra kilometres driven will be charged at \$0.28 per kilometre. Extra days may be available and can be requested at the time of booking. Extra days are subject to availability and are charged at the standard daily rental rate at the time of booking. Each extra day includes an extra 300 free km. One way fees are not charged for relocation bookings.

Free Kilometres

Vehicle Pickup & Return

All relocation vehicles must be collected and returned during branch operating hours. Vehicles must be collected at least 1 hour prior to the branch's closing time and returned at least 1 hour prior to the branch's closing time. Any vehicle not returned by this time will incur a late fee of \$500. All vehicles are to be collected and returned directly to our branches.

Kitchen & Linen Kits

Kitchen and linen kits are supplied in all relocation bookings unless stated at the time of booking.

Additional Drivers

Additional driver fees are charged at \$5 per day per additional driver.

Travel Restrictions

All relocation vehicles can only be driven on sealed roads or on well-maintained access roads less than 500 metres long to a recognised campground. Night driving from 7pm to 6am is not permitted. If you are found to have driven on unsealed roads or night driving it will be seen as a Substantial Breach in regard to the Rental Agreement.

Fuel Allowance

If your relocation includes a fuel allowance please ensure the agreed amount is noted on the Rental Agreement at pick up. The vehicle will be rented with a full tank of fuel and will need to be returned with a full tank of fuel. The fuel allowance will be refunded up to the amount on the contract, upon return of the vehicle (fuel receipts required). The refund will be onto your credit card when the vehicle is returned to the correct location and on time.

Free Spirit Of Tasmania Offer (free travel on ship)

If your relocation includes a free Spirit of Tasmania offer, Cruisin' Motorhomes will book the cheapest available ship. We will pay the ship costs of the vehicle and the driver. Any extra passengers or accommodation upgrades will be at the renter's expense. We will supply your ship booking number at the time of booking the relocation. Standard Liability

Cruisin' Motorhomes relocation rental charge includes a Standard Liability of \$1000. A security Bond of \$1000 will be collected at the time of entering into the Rental Agreement. Payment of this security bond is only accepted by credit card. The \$1000 will be debited from the credit card account.
